2. Contracts must be signed and returned to the Gospel Light Worldwide office, with the advance royalty fee, within 90 days of the date of Contract or the intent to contract shall automatically be deemed null and void.
3. The publisher shall not translate or publish any edition of any book prior to receiving a fully executed publishing agreement that has been signed by all parties involved.
4. No translation copies will be sent until all contracts and advance fees have been received.
5. No more than 5 different books from Gospel Light Worldwide shall be sent when reading copies are requested. An additional request can be made after the books initially requested have been reviewed and decided upon.
6. It is Gospel Light Worldwide's policy not to offer options on any book.
7. Publisher agrees to issue all royalty reports and royalty payments in accordance with the schedule set forth in the Contract. Should the publisher be unable at any time or for any reason to meet these deadlines, they will provide Gospel Light Worldwide with advance written notice.
8. If the Publisher elects to submit their own internal report form, the Publisher does hereby agree to provide all of the information outlined on the attached Book Statement Report.
